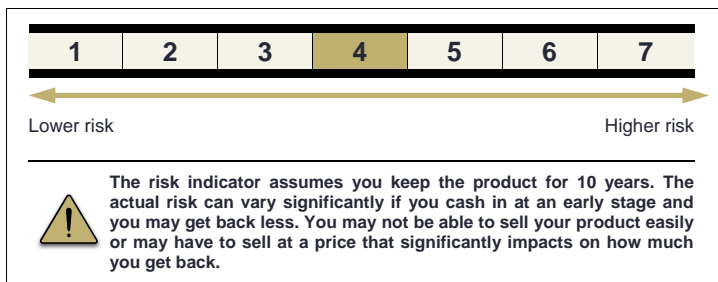
You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

Objectives	Within the investment option Wealins Life Norway - Investment profile FAS Aggressive between 0% and 25% of the capital will be invested in bonds, money market instruments and/or comparable assets and up to 100% in shares and/or other speculative financial instruments.
Intended retail investor	The targeted investor for Wealins Life Norway - Investment profile FAS Aggressive is willing to accept a very high risk of very significant depreciation of his investment while aiming for a very significant increase of his capital and having an extremely sound knowledge of the financial markets.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk Indicator

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level.
